Subject: Declaration of result of UGC - NET June 2024 - reg.

The National Eligibility Test (NET) is conducted on behalf of University Grants Commission (UGC) for determining the eligibility of Indian nationals for (i) 'award of Junior Research Fellowship and appointment as Assistant Professor', (ii)'appointment as Assistant Professor and admission to Ph.D.' and (iii) 'admission to Ph.D. only' in Indian universities and colleges.

The UGC – NET June 2024 was conducted by NTA in Computer Based Test (CBT) mode for **83 subjects** spanning over **11 days** in **21 shifts** in **280 cities** across the country for **11,21,225 candidates**, as per the following schedule:

To make the examination system transparent, the Question Paper, Provisional Answer Key(s) and Recorded Responses of the concerned candidates were hosted on the NTA website <u>https://ugcnet.nta.ac.in</u> from 07th September to 14th September 2024 (two phases) to invite challenges. Challenges received were verified by the experts and results prepared as per the answer keys finalized by experts.
